Description

MIG is a cross-sectional file for each head of household that migrated to the U.S.

MIG Variables

MMP174 – MIG file contains 9,052 observations and 612 variables. MIG is a person-level file containing details of all undocumented border crossings (up to 30) by each head of household, as well as measures of economic and social activity during the last U.S. trip.

Once the PERS file is constructed, then we selected only heads of households who reported at least one trip to the U.S. From PERS, we bring to MIG the person's background information from table A, health information from table Q and U.S. migration information from tables D and D2, and then merge all the following variables:

- Undocumented border crossings (table K).
- Migratory experience of family-of origin of head of household (table G).
- U.S. migration experience among extended family and friends (table H).
- Social, employment, and financial characteristics during the last U.S. trip (tables L and M).
- Benefits and assistance received during the last U.S. trip (table N).
- Detailed information pertaining temporary workers if migrant traveled under an H2 visa (tables R and S).

It seemed that the problem was the fact that these quantities were reported in pesos and not in dollars. We only adjusted 2.9% of our original observations, which we considered questionable. Amounts were adjusted to nominal dollars for communities surveyed prior to 2013.
